### **3. Information & Proposals**

a. Response to Delegations – verbal

Shawn Wilson, Chairperson reported that the Board has responded in writing to the two delegations who presented at the January 19th Regular Board meeting. The delegations were from the Surrey Schools Coalition and the Green Timbers Elementary PAC Vice President.

b. Inclement Weather, Snow Days - verbal

Dr. Jordan Tinney, Superintendent reported that the school closures the previous week were unprecedented. He extended his thanks and appreciation to the employees, mostly CUPE who continued to work through the closures to clear snow and ice. He also commented that these are difficult decisions, acknowledging that the decision affected not only students and staff but families in Surrey.

Trustees commented on emails they had received supporting the decision and added their thanks to CUPE and staff, noting that Dr. Tinney was out in the field checking out conditions with the safety of students, staff and families at the centre of the decision to close schools.

Chairperson Wilson commented on the extraordinary events that took place and read an email from DPAC who had received many comments from parents in support of the closures.

c. Trustee Reports

Chairperson reported on Trustee activities since the last Board meeting. A copy of the report is on the website. Demonstration of his concern for safety.

d. Capital Announcement - verbal

Shawn Wilson, Chairperson reported that Mike Bernier, Minister of Education, MLAs and City Councillors were in attendance on January 26<sup>th</sup> at the District Education Centre for a Capital announcement. Minister Bernier announced that the government, in partnership with Surrey School District, would open a Capital Project Office dedicated to building new student spaces faster. In addition, the government announced \$217 million in funding to support the projects.

Chairperson Wilson commented that the Board is very pleased with the announcement. With this funding and the 100 million announced in the spring there will be significant progress in providing student seats. He indicated that the first meeting for the Project Office will be held in a week's time.
