b. <u>Summer Learning Enrolment Report 2018</u>

Jordan Tinney, Superintendent provided a report on Summer Learning Enrolment for 2018. He noted that 12,000 students are enrolled in various programs, in multiple sites. Regular maintenance in schools will be scheduled accordingly

c. Progress Report on Active Capital Projects

Greg Frank, Secretary-Treasurer introduced Larry Harder, Director Capital Project Office who provided the Trustees with highlights from the monthly progress report on active capital projects being planned or under construction in the district. He noted that the tenders for Site 184 and 206 have come in significantly over budget. Currently the District along with the Ministry and Partnerships BC are doing a review of these projects.

Until the review is completed and ministry approval received, the impact on the two sites is unknown.
