The Restrictive Covenant, in favour of the City of Surrey, is required for New Water and Sanitary Connections as indicated on the attached plan in **blue**.

THAT the Board's signing officers execute the Restrictive Covenant: Land Title Act S.219 agreement.

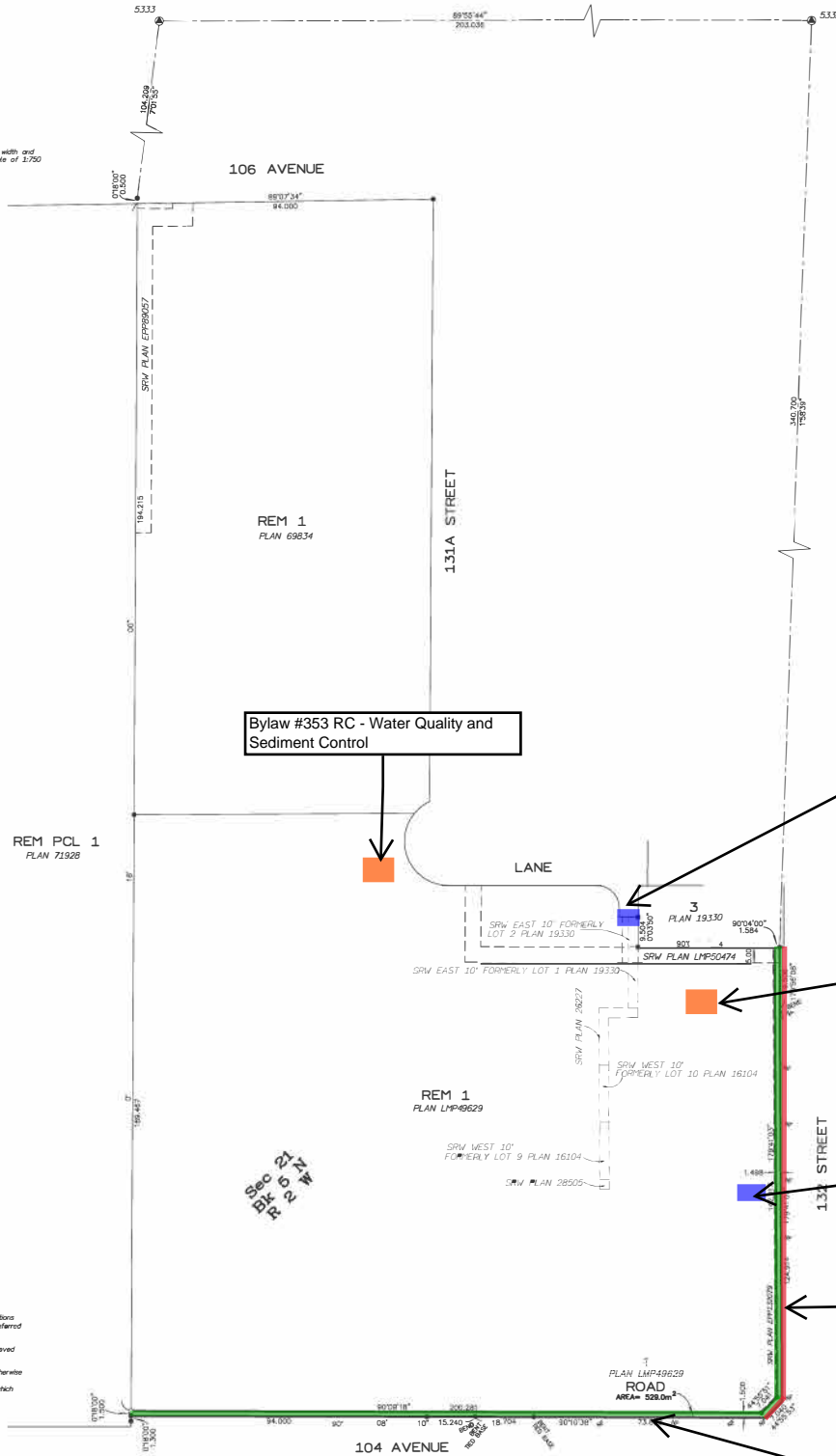
