Re: **SCHOOLS CLOSED TO OUT-OF-CATCHMENT REGISTRATION
(ELEMENTARY AND SECONDARY) – 2019/2020**

This memo provides an exception to Board Policy #9320 and Regulation #9320.1 designating schools where existing and/or projected enrolment exceeds the building capacity to the extent that out-of-catchment registration requests cannot be accommodated. Schools that are closed to out-of-catchment registration are reviewed on an annual basis, prior to the opening of registration.

The schools listed below are designated as closed to out-of-catchment registration for the 2019/2020 school year. These schools are closed to out-of-catchment registrations (other than siblings) from the date of this memo, and no out-of-catchment waitlist will be maintained.


Secondary Schools:
