- The Surrey School District has a long, history of successful extended field studies for students
- Schools in Surrey participate in over 400 extended field studies per year
- These range from local experiences such as athletic events, robotic competitions, or band festivals to international experiences







- Extended Field Studies are defined as field studies involving absences from the lower mainland for more than 3 consecutive days, higher risk activities, or international travel
- Surrey schools participate in approximately 60 extended field studies involving international travel each year

International Field Studies — Covid-19

- Covid-19 has disrupted or altered many facets of people's lives and work
- With the onset of Covid-19, the Surrey School District had to cancel 53 international field studies
- With such a significant world event comes the need to pause and adjust how the District facilitates and supports extended field studies moving forward

Extended Field Studies – Policy & Regulation

- Significant policy and regulations are already in place
- Extended Field Studies are governed by Policy 8901 and Regulation 8901.1 and 8901.2
- These include allowable destinations, duration away from school, supervision ratio, supervisor responsibilities, first aid requirements, student conduct, drugs/ alcohol/vaping, financial controls, and conflict of interest
- All Extended Field Studies requires the approval of the school principal and the assistant superintendent



REGULATION #8901.1 STUDENT FIELD STUDIES - GENERAL

1. CURRICULUM OBJECTIVES

- 1.1. Student field studies are to be directly related to the curriculum and undertaken only to enhance or add value to the learning experience beyond that which is available in the classroom.
- 1.2. Specific educational objectives for the learning experience are to be clearly in mind prior to planning the field study and subsequently, all activities should be directed to achieve these ends.
- 1.3. Evaluation of field studies is recommended to determine that the field study, as a whole, has enhanced the classroom learning experience commensurate with the costs and risks involved.

PLANNING

2.1. Educators-in-Charge will obtain the preliminary approval of the principal for field studies before communicating with parents, making commitments or commencing findersicing.

Extended Field Studies – Policy & Regulation

The proposed changes to policy & regulations are intended to:

- (i) Increase the safety of staff and students and the District's ability to respond to emergencies
- (ii) Increase financial protection for our parents/guardians and the Board of Education in the event an extended field study is cancelled
- (iii) Provide clarity to the educators who organize these field experiences

Extended Field Studies – Proposed Regulation Changes:

- 1. Requiring all extended field studies involving out-of-province travel, or air travel, to be arranged through one of the District pre-approved travel service providers.
 - This provides an added level of protection
 - It allows for the District to work with companies who can respond in the event of an emergency
 - It allows for consistency of contract terms and conditions

Extended Field Studies – Proposed Regulation Changes:

- 2. Requiring all extended field studies involving out-of-province travel, or air travel, to purchase trip cancellation insurance for all participants as part of the cost of the trip.
 - This allows for consistency of contracts and coverage
 - This ensures all participants have are covered financially in the event the trip is cancelled
 - This ensures there are no surprises for our parents/guardians

Extended Field Studies – Proposed Regulation Changes:

- 3. Requiring payment for extended field studies to be made by cheque from a school account or by P-card. Personal credits should only be used for emergent expenses arising during the field study.
 - Financial controls are already in place
 - Making this requirement explicit in the extended field study regulation
