The purpose is to collect all drainage water from all paved areas and approximately 95% of the landscaped area of the Lands prior to discharging the drainage water into the storm drainage system. The School District will operate, maintain, and replace when necessary at no cost to the City.

THAT the Board's signing officers execute the Restrictive Covenant: Land Title Act S.219 agreement.

The installation of the works will have no adverse effect on the use of the site by the school district; or our ability to dispose of the site in the future.


